TERMS & CONDITIONS

Admissions: The ILI-SACE CWRU Financial Integrity Courses are designed to provide students with a unique, comprehensive and practical education in different aspects of preventing illicit international financial flows. Seats to these courses are limited and CWRU and ILI-SACE ("organisers") reserve the right to admit or deny admission to applicants on the basis of their qualifications, as well as on the basis of space for each respective course. The minimum educational criterion for all courses is an undergraduate degree or equivalent, though individuals without an undergraduate degree, but with relevant or related professional experience or interest, may be admitted to a course. All courses are facilitated in English. Written and spoken English proficiency is required for participation in all courses.

Notification: Upon submitting an application to attend a single MAFI course, an applicant will receive acknowledgement via email from ILI-SACE. Following this, there will be email notification on the outcome of the application with guidance on the next steps.

Course fees: The tuition fee per course is US \$2,200. Course fees include only the cost of tuition and a jointly issued ILI-SACE and CWRU certification of completion. The fee does not include any costs for travel, accommodation or meals during in-person sessions.

Credit: Participants who obtain a grade of B- or higher will receive credit for the course which will exempt them from taking the course again if they apply to, are accepted by, and begin the MAFI degree programme within five years of completing the course.

Application Deadlines: Applications must be received at least one month prior to the start of the course to be attended.

Payment: Full payment is a requirement for enrollment. The organisers reserve the right to refuse admission into the course where proof of payment has not been received prior to commencement of the course.

Class times: Classes will meet over four days as follows (Central African Time/South African Time):

Location: Classes will meet via Zoom as mandated by the Coronavirus Pandemic and as soon as will be possible, via

in-person sessions in Johannesburg, South Africa. There will also be one course offered in Cleveland, Ohio (see list of courses on page 4), which students may attend in-person or remotely.

Cancellation: If we cancel a MAFI course, tuition for that course will be fully refunded.

Withdrawals and Substitutions:

- A 100 percent refund will be issued to a registered participant if a completed withdrawal request is received prior to five business days before the start date of the course.
- A 50 percent refund will be issued for withdrawal requests received on or after five, but prior to three business days before the start date of the course.
- There is no refund for withdrawal requests received on or after three days prior to the start date of the course; no exceptions will be made.
- If a candidate must for some reason withdraw from the course after admission but before classes begin, the candidate's sponsor may request permission to substitute another person, subject to review of the second person's qualifications for admission by the course organisers.
- Withdrawal requests must come directly from the participant or his/her designee; the official receipt date is the day and time the request is received by the ILI-SACE office via email to admissions@ili-sace.org.
- The organisers will not provide refunds for any participant who is recalled or leaves the course for any reason after the commencement but before the conclusion of the course.

Intellectual Property: All intellectual property rights in the materials distributed by the organisers in connection with the courses are retained and are expressly reserved by the organisers, and any unauthorised duplication, publication or distribution is prohibited.

Full Attendance: Full participation in all sessions is required for participants to receive certification for the course.
